We connect to audiences through inspiring, accessible, world-class opera and stimulating, creative participation programmes.

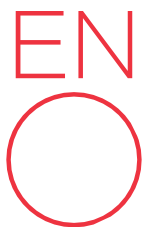
We create our productions for the widest possible audiences and aim to introduce completely new audiences to the magic of opera whether at the London Coliseum, outside of our theatrical home or internationally.

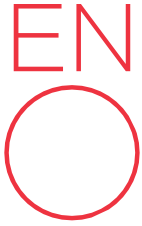

## Lighting Technician

### Key Accountabilities

- To receive instruction from the Lighting Managers (or Senior Technicians) daily and carry out those tasks reliably and efficiently and safely
- To be aware of the technical requirements of specific productions to support the efficient running of performances
- To safely operate the department's equipment to a high standard, plotting and running shows and rehearsals
- Generating and up-dating plots, set up notes and cue sheets to provide accurate and accessible records of shows and their running requirements
- Communicating at the appropriate level within the Lighting department and across the Technical Department to facilitate the Rep and to maintain the highest standards of operation
- Ensuring that all activities are carried out in accordance with the Organisation's Health and Safety Policy and establish that other Technicians as appropriate are aware of these requirements
- Actively participating in risk assessments and reporting accidents, incidents, near misses and hazardous situations
- Understanding and collaborating with other departments especially Stage, Production, Sound and Video and Stage Management to fulfil the requirements of each production and the repertory season
- Maintaining a system of housekeeping and storage of equipment, to facilitate the efficient running of the repertory season
- Undertake any other duties as reasonably required, in line with the scope and responsibilities outlined in this job description



## Lighting Technician

### Person Specification

#### Required:

- Ability to focus a variety of instruments quickly and accurately under instruction
- Familiarity with current lighting equipment and associated accessories
- Ability to rig equipment in accordance with current H&S regulations
- Ability to accurately read and understand a lighting plan and extract relevant information from it
- Ability to make running plots or follow spot plots during the on-stage rehearsals
- A working knowledge of automated fixtures
- An understanding of Ethernet/DMX networks
- Ability to undertake routine maintenance and first line repair of automated fixtures
- A good knowledge of all relevant Regulations appropriate to the post
- Ability to carry out fault finding, running repairs and maintenance
- A basic knowledge of electricity and electrical safety
- Ability to follow spot
- Confidence to work safely at height
- A broad understanding of the workings & requirements of other technical departments

#### Desirable:

- A working knowledge of ETC desks, basic electronics and VectorWorks
- A working understanding of Data Networks in the Entertainment industry
- An understanding of Electrical Safety Standards and BS7909
- Basic Rigging competence, truss assembly etc.
- IPAF Category 3a licence (training will be given if required).
- IRATA or other accredited Working at Height certificate (training will be given if required)
